2001	Signing of a partnership agreement: each board member becomes a shareholder.
2007	Founding of T&P Trustee and Protector Sagl, active in the field of foreign law trusts.
2010	Full acquisition of fidbe SA (formerly Fiduciaria Elio Bernaschina SA), Riva San Vitale, later merged into Fiduciaria Mega SA in 2021.
2013	Full acquisition of Fideconsul Società di Revisione SA, Chiasso.  Geo Camponovo, one of the founding members, takes over as Honorary President until 2018, when he passes away.
2022	Full acquisition of Steimle & Partners Consulting SA, Lugano.  In December, our Riva San Vitale office relocates to the historic Swiss Federal Railways station building in Mendrisio.
2026	In January, 100% of LCA Tax Consulting SA in Locarno is acquired.
